

## MANIFESTO FOR CIVIC DISOBEDIENCE against MASK OPPRESSION and MANDATORY VACCINATION

The dehumanity of certain political choices leads to  
Non-violent Civic Disobedience

### BUT WHAT IS CIVIC\* DISOBEDIENCE?

- ⚠ When **the Government** yields its mandate to the Financial System, protects private interests at the expense of the public interest, and forecloses Human Rights
- ⚠ When **Justice** contributes to the creation of a Security Order based on fear
- ⚠ When **Law** and **Ethics** further the interests of Technochemistry to the detriment of Nature's intelligence; when sharing information becomes a crime and ratting a virtue
- ⚠ When **the Media** exercise censorship in the service of a corrupt one-track thinking
- ⚠ When **official Medicine** violates the commitments of the Hippocratic Oath and perverts its first precept: *First, do no harm*
- ⚠ When **a majority of Humans** are mesmerized into passively renouncing their most vital function, the 1<sup>st</sup> factor of regeneration: to Breathe Freely and without hindrance

WHAT CAN CITIZENS, HEALTH PROFESSIONALS, ELECTED OFFICIALS, JURISTS, POLICEMEN and JOURNALISTS do to restore the law as a tool for preserving the common good and public health? **TOGETHER:**

#### Organize a peaceful resistance to State injustice!

**6 criteria** must be present to qualify an act of civic disobedience\*:

**It is a personal and responsible act:** disobeyers act to remain consistent with their convictions. They know the legal risks and are willing to assume them: they prefer to stand accused before a court of law rather than their own conscience.

**It is a disinterested act:** disobeyers contravene a law they consider contrary to the public interest. They derive no personal benefit.

**It is an act of collective resistance:** disobeyers rally support for a cause requiring a break with legality. Their act promotes solidarity.

**If thousands of objectors disobey, the impact is increased and the risk lessened**

**It is a non-violent act:** it requires self-control and respects the integrity of the opponent. Precisely, one goes after the very things that damage people's integrity.

**It is a transparent act:** disobeyers act with their face uncovered.

**It is a last resort:** disobeyers take action after exhausting all human and institutional means of dialogue within their reach.

#### VACCINATION TABOO: YOU WON'T BE ABLE TO SAY "WE DIDN'T KNOW"\*\*\*

Civic (or civil) disobedience is not an attempt to dismantle society but an endeavor to build it differently. It is a political act that sets accountability against infantilization and domestication, legitimacy against legality.

**Civic disobedience demands and produces law.**

**The Declaration of the Rights of Man and of the Citizen establishes the legal nature of civic disobedience by recognizing "the right to resist oppression" and "the state of necessity"**

## SERVING MANKIND AND LIVING THINGS Non-violent Civic Disobedience is a decisive force over time HISTORY HAS PROVEN ITS EFFECTIVENESS

In emergency situations, between passivity without commitment and violence without hope, a third path, **non-violent action - legal or not - has proven its worth.**

**Long is the list of those who have resisted and disobeyed for the common good.** Yesterday's offenders are honored for their services to posterity, as will one day be the non-violent citizens and activists who are censured and condemned today.

#### Their story is an example and a model of civic education

**Mohandas GANDHI** (1869-1948):  
*fought against segregation in South Africa, trained thousands of Indians in non-cooperation with a despoiling State and called millions to disobedience in order to obtain India's independence. With him, conscientious objection became a real collective force.*

**Martin Luther KING** (1929-1968):  
*with the boycott of segregationist buses, he rallied the support of the crowds for the recognition of the civil rights of Black people, then defied the State by committing against the Vietnam War financed at the expense of the poorest. Nobel Peace Prize in 1964 (...)*

- ☯ **CONSCIENTIOUS OBJECTORS** against the Algerian war (France) and other "dirty wars"
- ☯ **GMO MOWERS** for the right to freely grow and eat healthy food
- ☯ **OPPONENTS OF MASS ANIMAL VACCINATION**, linked to agro-industrial abuses
- ☯ **ACTIVISTS FOR VACCINAL FREEDOM**, for the recognition of the crucial role of childhood diseases in the maturation of our immune, endocrine and nervous systems, for a healthy lifestyle that preserves our innate capacity for self-regeneration\*\*
- ☯ **WHISTLEBLOWERS** wherever opacity, misinformation and corruption reign

#### Forgotten by History and obscured by Science

**Alfred R. WALLACE** (1823-1913), co-discoverer with Darwin of the theory of evolution, he sued for the abolition of the "CRIMINAL" LAW on mandatory vaccination.

**Antoine BECHAMP** (1816-1908), ignored father of modern molecular biology, immunology, microbiology and virology, he demonstrated from the outset the fundamental error of Pasteur, baseless mainstay of a mechanistic, alienating and warlike medicine that hinders terrain medicine and makes the industry's heyday.

**The cohort of scientists from the 19th century to the present day, published authors of hundreds of studies deconstructing the Pasteurian dogma\*\* which preaches an absurd and debilitating struggle against our own physical system and culminates in vaccination.**
